
The perfume-free and dye-free formulation did not demonstrate a potential for eliciting dermal irritation or sensitisation after conducting an independent 6 week Human Repeat Insult Patch Test (HRIPT).

# **Repeat Washing Test**






# **Cleaning Efficacy Test**


Cleaning Efficacy Testing


# User Preference Testing


N = 54 worker responses taken following 6 week Estesol® FX™ PURE trials
